INVESTOR SERVICE REQUEST (ISR)

The Securities and Exchange Board of India ('SEBI') vide its circular Nos. SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2021/655 dated November 03, 2021 & SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2021/687 dated December 14, 2021, has made it mandatory for the shareholders holding securities in physical form to furnish PAN, KYC details and Nomination details to the Registrar and Share Transfer Agent of Ramsons Projects Limited ('the Company') i.e. Link Intime India Private Limited ('RTA').

All holders of physical securities are mandatorily required to submit the following information / documents / details to RTA effective from January 01, 2022:

- PAN
- Nomination details
- Contact Details including Postal address with PIN code, Mobile Number, E-mail address.
- Bank account details including Bank name and branch, Bank account number, IFS code, Demat account number.
- Specimen signature

Further, SEBI vide its Circular No. SEBI/HO/MIRSD/MIRSD-PoD-1/P/CIR/2023/37 dated March 16, 2023, simplified norms for processing investor's service requests by RTAs and norms for furnishing PAN, KYC details and Nomination.

The folios of the holders of physical securities who have not furnished PAN, KYC details and Nomination details to the RTA shall be freezed by RTA on or after October 01, 2023.

Further, The RTA shall revert the frozen folios to normal status upon receipt of PAN, KYC details and Nomination details from the security holders.

For updating PAN and other KYC details, the shareholders are required to submit, duly filled, Form ISR-1.

In case there is major mismatch in signature of the holder or if the signature is not available with the RTA, the shareholder shall furnish the original cancelled cheque with name of the security holder printed on it / Bank Passbook / Bank Statement attested by the Bank, and Banker's attestation of the signature as per Form <u>ISR-2</u>.

Shareholder shall continue to use Form <u>SH-13</u> and <u>SH-14</u> for declaration of nomination and for cancellation/change in nomination, respectively. However, in case a shareholder wants to opt-out of nomination, Form ISR-3 shall be filed.

Further, as prescribed by the Income Tax Authorities, please link your PAN with Aadhaar by March 31, 2023, in order to avoid freezing of your folio. Further, in case of failure to provide required documents and details as per the aforesaid SEBI circular, all folios of such

shareholders shall be frozen on or after April 01, 2023, by the RTA or by any extended timelines, if any, notified by SEBI in this regard.

Frozen folios will be referred by the RTA or the Company to the administering authority under the Benami Transactions (Prohibitions) Act, 1988 and/or Prevention of Money Laundering Act, 2002, if they continue to remain frozen as on December 31, 2025.

Also, the shareholders holding shares in physical form may make a request to the Company and the RTA for issuance of Duplicate certificate, Claim from Unclaimed Suspense Account, Replacement / Renewal / Exchange of securities certificate, Endorsement, Sub-division/ Splitting of securities certificate, Consolidation of securities certificates/folios, Transmission and Transposition in Form <u>ISR-4</u>.
